#### **Explanatory Note on Ordinary Business:**

##### **1. Audited Financial Statements for the financial year ended 31 December 2024**

This agenda is meant for discussion only as under the provisions of Section 340(1) of the Companies Act 2016, the Audited Financial Statements do not require formal approval of the shareholders. Hence, this item of the Agenda will not be put forward for voting.

##### **2. Ordinary Resolution 1 – Final Dividend**

On 25 April 2025, the Board of Directors ("the Board") of the Company announced the declaration and payment of Final Dividend of 4 sen per ordinary share for the financial year ended 31 December 2024 subject to shareholders approval being obtained at the 57<sup>th</sup> AGM. If passed, the dividend will be paid on 18 July 2025 to shareholders whose name appears on the Record of Depositors at the close of business on 1 July 2025.

##### **3. Ordinary Resolution 2 and 3 – Directors' Fees and Directors' Benefits**

Pursuant to Section 230(1) of Companies Act 2016, the fees of the directors and any benefits payable to the directors of a listed company and its subsidiary shall be approved at general meeting. In this respect, approval of shareholders is sought on the directors' fees for the financial year ended 31 December 2024. Approval from shareholders is also sought on the payment of director's benefits for the period from 1 January 2025 until the next annual general meeting in 2026.



**4. Ordinary Resolution 4 to 7** on Re-election of Directors, Mr. Ling Lu Kuang, Datu Hasmawati Binti Sapawi, Mdm Ling Pau Pau and Datu Sr. Zaidi Bin Haji Mahdi

Mr. Ling Lu Kuang, Datu Hasmawati Binti Sapawi and Mdm Ling Pau Pau will retire at the 57<sup>th</sup> AGM in accordance with Article 93 of the Constitution of the Company whilst Datu Sr. Zaidi Bin Haji Mahdi will retire in accordance with Article 100 of the Constitution. The profiles of the retiring Directors are set out in the Profile of Board of Directors section of the Company's Annual Report 2024.

The Nomination Committee has taken into account the Board Evaluation Assessment including the results of assessment of retiring Directors and concurred that they have met the Board's expectation in terms of experience, expertise, integrity, competency, commitment and individual contribution by continuously performing their duties diligently as Directors of the Company. The Board recommended them to be re-elected as Director of the Company.

**5. Ordinary Resolution 8 – Re-appointment of Auditors**

The Group Audit Committee has carried out an assessment of the suitability, objectivity and independence of the external auditors, Messrs. KPMG PLT ("KPMG PLT") and was satisfied with the suitability of KPMG PLT based on the quality of audit, performance, competency and sufficiency of resources the external audit team provided to the Group.

The Board therefore approved the Group Audit Committee's recommendation on the re-appointment of KPMG PLT as the external auditors of the Company be put forward for the shareholders' approval at the forthcoming 57<sup>th</sup> AGM.

**6. Ordinary Resolution 9 and 10 – Proposed Retention of Independent Non-Executive Director**

Pursuant to Practice 5.3 of the Malaysian Code on Corporate Governance published in April 2021, the tenure of an independent director should not exceed a term limit of 9 years. Upon completion of 9 years, an independent director may continue to serve on the Board as a non-independent director. If the board intends to retain as independent director beyond 9 years, shareholders' approval must be sought through two-tier process and the Board must provide justifications for the retention.

The proposed Ordinary Resolution 9 and 10 are intended to retain Mr. Fong Yoo Kaw @ Fong Yee Kow, Victor and Mr. Chua Chen San who have served as Independent Non-Executive Directors of the Company for a term limit of more than 9 years but less than 12 years and recommended them to continue to act as Independent Non-Executive Directors of the Company.

The Nomination Committee has assessed the independence of Mr. Fong Yoo Kaw @ Fong Yee Kow, Victor and Mr. Chua Chen San on the following justification: -

- (a) Mr. Fong Yoo Kaw @ Fong Yee Kow, Victor and Mr. Chua Chen San have fulfilled the criteria stated under the definition of Independent Director as defined in the Main Market Listing Requirements of Bursa Malaysia Securities Berhad and Mr. Fong Yoo Kaw @ Fong Yee Kow, Victor and Mr. Chua Chen San would be able to provide proper check and balance thus bringing an element of objectivity to the Board.
- (b) Their length of services on the Board for a cumulative term of more than 9 years does not in any way interfere their exercise of objective judgement or their ability to act in the best interest of the Company and the Group. In fact, they are familiar with the Group's business operation and have always actively participated in the Board and Board Committee discussion and have continuously provided an independent view to the Board; and



- (c) They have exercised due care during their tenure as Independent Directors of the Company and have discharge their duties with reasonable skill and competence, bring independent judgement into decision making of the Board and in the best interest of the Company and its shareholders.

**7. Ordinary Resolution 11** – Proposed Shareholders' Mandate for Recurrent Related Party Transactions of a revenue or trading nature:

If passed, will authorize the Company and/or its subsidiary companies to enter into Recurrent Related Party Transactions of revenue or trading nature. This authority, unless revoked or varied by the Company at the general meeting, will expire at the conclusion of the next Annual General Meeting of the Company.

**8. Ordinary Resolution No. 12** – Proposed Authority to issue and allot share pursuant to Sections 75 and 76 of the Companies Act 2016.

The Board continues to consider strategic opportunities to broaden the earning potential of the Company and this may involve equity deals which may require the Company to issue new shares. If passed, it will grant authority to the Directors to issue shares pursuant to Sections 75 and 76 of the Companies Act 2016 and will provide flexibility to the Directors to undertake any possible fund raising activities, including but not limited to further placing of shares for the funding of the Company's future investment projects, working capital and/or acquisitions, by issuance of shares at any time up to an aggregate amount not exceeding 10% of the total issued share of the Company for the time being for such purposes as the Directors consider would be in the best interest of the Company.

The Company did not utilize this Shareholders' Mandate that was approved in 56<sup>th</sup> Annual General Meeting. This authority, unless revoked or varied by the Company at a general meeting, will expire at the conclusion.

**9. Ordinary Resolution No.13** – Proposed Granting of ESOS Options

If passed, will authorize the Company to offer and grant ESOS Options under Company's Employees' Share Option Scheme ("ESOS") as approved by the Shareholder on 9 August 2017, to eligible Directors and empowers the eligible Directors to subscribe the proposed allocation of ESOS Options, in accordance with the Constitution of the Company and By-Laws of ESOS dated 9 August 2017.

In addition, Directors will abstain from voting on resolutions pertaining to their respective specific allocation of ESOS Option as well as the specific allocations to any persons connected with them (where applicable).
